

SELLING YOUR CAR @ Houston Auto Auction

- ✓ Your title must have your name printed on the front as owner. Your title must also be a "clean" title. This means if there is a lien holder listed you must have either a signature release of lien on the front of the title or an attached Release of Lien form.
- ✓ You must show valid photo identification to prove ownership.
- ✓ Your vehicle must have a current inspection sticker that is good for 30 days after the date you register it for sale. If you do not have this, your vehicle can still be sold through our auction, but it will be limited to dealers only.
- ✓ If your vehicle is titled or registered in a county other than a special emissions county, then you will need to have a Safety Inspection Emissions Form attached to the title. This form must be dated within the last 90 days. If you do not have this form, your vehicle can still be sold through our auction, but it will be limited to dealers only.
- ✓ You must submit your vehicle at least a day before the auction. Auction day registration is permitted, however your vehicle will not be run until the following auction. We have auctions every Wednesday and Saturday. No vehicle will be run through our auction without the seller's original signature on our Consignment Contract. Please see Consignment Contract Rules below for the rules listed on this contract.
- ✓ When submitting your vehicle, you must give phone numbers where you can be reached both on Wednesday and Saturday. Failure to do this may result in having an acceptable bid rejected because we could not reach you for bid approval.

Consignment Contract Rules

- **INSPECTION STICKER:** Current inspection good for 30 days after sale date is required.
- **TOWS (DEALER AND INDIVIDUALS):** Inoperable vehicles will not be accepted for auction unless the owner agrees to accept the high bid AND leaves a signed title with Houston Auto Auction prior to the sale.
- **INDIVIDUAL SELLERS FEES:** If sold, 10% of sale price up to \$5000 plus 3% of portion of sale price over \$5000 with a \$60 minimum. A \$25 turn down fee is applied if not sold. Heavy Equipment - \$75 turn down fee or 10% of sale price with \$25 minimum on misc. equipment & \$75 minimum on trucks, no maximum
- **ARBITRATION FEE:** Buyers are entitled to a 10 mile test drive and have the right to return a vehicle for arbitration for unannounced defects. If the complaint is upheld or if the seller refuses arbitration analysis, the consignor is subject to a \$100 arbitration fee.
- **STORAGE:** Any vehicle left over 10 days after last auction run will incur an \$11 / day storage fee.
- **DAMAGE:** Houston Auto Auction is not responsible for damage to consigned vehicles or for theft of any accessories, including radios.

Directions to Consignment Entrance

Please take all vehicles for sale to our Consignment Entrance.

FROM DOWNTOWN HOUSTON:

- Take I-45 South towards Galveston. Exit GRIGGS / BROAD ST. Stay left and go underneath the GRIGGS street bridge. Stay on feeder road past BROAD street. Turn right on GULF FLOW (Ace Mart is on corner). Consignment Entrance is at the end of GULF FLOW on the left.

FROM SOUTH OF 610 LOOP:

- Take I-45 North towards downtown. Exit BROAD ST. / S. WAYSIDE DR. Turn left on BROAD street. Turn left on feeder road. Turn right on GULF FLOW (Ace Mart is on corner). Consignment Entrance is at the end of GULF FLOW on the left.

FROM HOUSTON AUTO AUCTION LOBBY PARKING LOT:

- Exit parking lot and turn left on FLOWERS. Turn right on feeder road. Make a U-Turn underneath freeway at WOODRIDGE. Turn left on BROAD street. Turn left on feeder road. Turn right on GULF FLOW (Ace Mart is on corner). Consignment Entrance is at the end of GULF FLOW on the left.
